Mayor Paradis asked everyone to stand for a moment of silence and remember the folks in California and for the Pledge of Allegiance.

Call to Order

The January 14, 2025 regular meeting of the Bolivar Town Council was called to order by Mayor Stephen Paradis at 6:30pm. Councilperson Chris Higdon was absent for this meeting.

Treasurers Report

Treasurer Eric Lewis was not in attendance for this meeting. Mayor Paradis said we are at 50% of our budget. Any revenues above 50% are in our favor and anything running above 50% for expenses is against us. Gas and Oil Severance Tax is up but we did not budget that much. Councilperson Sarah Shafer asked about Visitors Bureau expenses. Mayor Paradis said Hotel Occupancy Income and Visitor's Bureau balance each other out because we owe the Visitors Center half of what we collect. Mayor Paradis said City Hall is down, City Attorney has nothing. Mayor asked Laura about this. Laura said Effie has not submitted anything. Laura said we have two invoices that need to be paid. Councilperson Victoria Gale asked if there were two funds for the Library. Mayor Paradis explained money comes from Gas and Oil Severance Tax and from Town of Bolivar for the Library.

Councilperson Victoria Gale moved to approve the December Treasurers Report as presented by Mayor Paradis. Councilperson Sarah Shafer seconded the motion. Motion passed 4-0.

Town Attorney, Effie Kallas

Attorney Kallas was not present for this meeting.

Mayor Paradis said he met with Effie, Sheriff Hanson and Tray on some wording to the contract that Effie is working on. Attorney Kallas will catch up with us next month.

Sheriff's Department Report and public comment

Corp. reported for the month of December we had 100 incidents. We had 55 Road Patrols, 10 Directed Patrols, 6 Building Checks, 5 Public Service, 2 Traffic Stops, 1 AssultNIP, 1 Cardiac Arrest-B, 1 Citizen Arrest, 1 Disturbance, 1Domestic PhysIP, 1 Foot Patrol, 1 Harassment, 1 Injured

Animal, 1 Special Event Law (Parade). Corp. Hockman said nothing new to report and nothing to keep him up at night. Mayor Paradis thanked Corp. Hockman for his report.

Harpers Ferry National Historical Park Report

Superintendent Gossett announced the Park has welcomed a new Resource Manager, Darlene Hassler, and Acting Facility Manager, Steve Smith to Harpers Ferry National Park.

- This is just a reminder that Deer Management operations started this week.
- We will be installing, repairing or replacing 70 windows in lower down town park (there may be some temporary delays due to using a lift to put the windows in place)
- Construction Bryon Bridge project will start in the spring and will be closed 4 to 5 months.
 This will have an impact on travel in the community. (We are working on bus transportation across the 340 bridge.
- The National Park Service will remove the silo from the Hinkle Farm located on Bakerton Road due to safety reasons. We did an environmental assessment on this project.

- Request from Matt Mullenex, Region 9 letter of support for Grant application needed by the end of January. I need more information to complete.
- Urban Deer bow hunting will start January 13-31. This is being organized by Laura Clark.
- I received an email from Mayor Vaughn about noise at The Barn. Talked to owners, Mayor, Citizens and Sheriff, just trying to understand. This issue may be on our next agenda.

Mayor Paradis asked Recorder Reed to speak about our upcoming Town Election.

Recorder Reed said due to inclement weather we did not hold our regular meeting on January 7, 2025. This is the first time this year we have met in person. The information was placed in our local newspaper "The Spirit of Jefferson" concerning the time and where to sign up to run for office. If anyone is planning to sign up to run for any of the positions of Town Council, Town Recorder, or Mayor, you will need to do the following.

- Bolivar Town Election will take place on Tuesday, June 3, 2025.
- Sign up time will be from January 13, 2025 thru January 25, 2025 by 12:00 noon
- Contact Bolivar Town Administrator, Laura Whittington during regular working hours for a Municipal Candidate's Certificate of Announcement.
- This form must be notarized and received in person or post-marked by mid-night, Saturday, January 25, 2025.

Bolivar Planning Commission

We have to put forth a flood plan ordinance that meets their approval. If we do not get the ordinance in place then those entities in the zone will not qualify for Federal Assistance in the case of a flood.

He will become a Town Administrator for Shepherdstown. He said this may present a conflict of interest since I am representing you and working for Shepherdstown. That would be up to you.
